METUNG YACHT CLUB BOAT STORAGE CONDITIONS

- The allocation of boat storage is at the complete discretion of the Club's General Committee or its Delegate.
- Boat and trailer owners must be financial members of the Metung Yacht Club Inc.
- To be eligible, a Boat must be on the Club Boat Register.
- Boats must be covered by Third Party Insurance of at least \$10 million at all times. A copy of the policy must be provided to the Club on application and when the policy is renewed.
- The storage fee applicable is to be paid in advance each financial year or part thereof, on receipt of an invoice from the Club.
- Boats and trailers are to be kept in a functional, neat and orderly manner.
- Boats may be stored with their mast up or horizontally on top of the boat unless one option is specifically required by the Club. Masts may not be stored on the ground.
- Masts which are stored horizontally must not protrude past the bow of the boat or the front
 of the trailer.
- The wheels of all trailers must be properly chocked to ensure they are unable to roll.
- The Club accepts no liability for any loss or damage to any boat or trailer stored on the Club's lease.
- The Club reserves the right to relocate boats and trailers as necessary to ensure the efficient management of its lease.
- The Club General Committee may withdraw boat storage rights at any time.
- Boats and trailers must be removed within 14 days of a notice being sent to the last known email or postal address of the member.
- A change of boat ownership means the storage arrangement with the Club ceases. A new owner must make a new storage application to the Club.
- Applications are for a maximum of 12 months and the owner must advise the Club before the
 end of the period if a renewal of the arrangement is desired. As long as these Conditions
 have been followed in the past, such a renewal will be assessed ahead of new applications.
- If insufficient storage spaces are available, an application may be put on a "waiting list" until a vacancy arises.
